

- After a demonstration in which she was present, an activist was charged with a crime related to the demonstration. As part of the case, the activist was granted access to documents, including body-camera video footage from a police officer near the demonstration. In the footage, the officer mentioned that two undercover officers were at the demonstration, and appeared to refer to one of them as “April, with her giant boobs.”
- Through “a process of elimination,” activists deduced that she was the infiltrator mentioned in the footage.

## **Michael Adam Windecker II (Mickey), 2020**

*Origin:* Civilian

Michael Adam Windecker II infiltrated demonstrations for racial justice in Denver. He worked for the FBI. He attended demonstrations. He accused other activists of being FBI informants. He asked an activist to illegally purchase a firearm for him, and the activist was later convicted of the illegal purchase. He carried out the infiltration under his real name.

He was exposed as a likely infiltrator in 2020 because he exhibited suspicious behavior, such as collecting activists' personal information, wearing a camera on his chest during demonstrations, and pushing people to commit crimes. He was confirmed to be an infiltrator by a journalist in 2023.

## **April Rogers (Chelsie Kurti), 2020–2021**

*Origin:* Police

April Rogers infiltrated leftist groups in Colorado Springs, including a socialist political organization and a tenants union. She was part of the Colorado Springs Police Department but her infiltration was carried out under the authority of the Federal Bureau of Investigation. She attended demonstrations and other events. On several occasions, she tried to push activists to illegally purchase firearms, presumably so they could be charged with the illegal purchases.

She was identified because:

## Shaquille Azir, 2011–2012

### Origin: Civilian

Shaquille Azir infiltrated an informal anarchist group in Cleveland, Ohio. He worked for the FBI. He first attended a protest, where he met an anarchist. He then formed an informal group with this anarchist and four others, and pushed them to plot the bombing of a bridge. The anarchists were arrested and each sentenced to approximately 10 years in prison.

## Heath Harmon, 2016

### Origin: Civilian

Heath Harmon infiltrated protests against the Dakota Access Pipeline. He worked for the FBI. He was recruited by the FBI after he contacted his brother, a police officer, and asked if he could help by infiltrating the protests. He participated in camps organized in opposition to the Dakota Access Pipeline. He was in a romantic and sexual relationship with one of his targets.

## Chris Dugger, 2008

*Origin:* Civilian

Chris Dugger infiltrated groups organizing against the 2008 Republican National Convention. He worked for the police. He attended meetings. On one occasion, he claimed to suspect another activist of being an informant.

## John Jacob Towery (John Jacobs), 2007–2009

*Origin:* Unknown

John Jacob Towery infiltrated anarchist and anti-war groups in Tacoma and Olympia in Washington state. He attended meetings, drove his targets to events, spent time in their homes, and gathered information from conversations he overheard. Claiming to be ex-military and to now work as a civilian in the IT department of a nearby army base, he used knowledge from his job to “help” an anti-war group.

He was identified partly because:

- His car was seen in the driveway of a house whose address was linked to his real name.
- His motorcycle's license plate was associated with an organization of motorcycle enthusiasts, and, on the organization's website, he was listed under his real name as a member who rode a motorcycle of the same make and model.
- When confronted with evidence, he confirmed being an infiltrator.

## Marilyn Hedstrom (Norma Jean Johnson), 2007–2008

*Origin:* Police

Marilyn Hedstrom infiltrated groups organizing against the 2008 Republican National Convention. She attended and helped organize meetings. Another infiltrator, **Rachel Nieting** (p. 52), posed as her niece.

## Andrew Darst (Panda, Andy, Pandy), 2007–2008

*Origin:* Civilian

Andrew Darst infiltrated groups in the United States, including anarchist groups and groups organizing against the 2008 Republican National Convention. He worked for the FBI. He attended meetings and other events. Hidden audio and video recording devices were hidden in his apartment to record activists who visited. He pushed an activist to make Molotov cocktails, and the activist was sentenced to 3 and a half years in prison.

## About the Infiltrators Database

The Infiltrators Database is a searchable database of cases of long-term infiltrators who have targeted groups engaged in subversive activities in the 21st century. Its goal is to help anarchists and other rebels understand how infiltrators operate.

### Inclusion criteria

To be included in the database, a case must be:

- **About an infiltrator,<sup>1</sup> not an informant.<sup>2</sup>** The infiltrator joined groups that they were not part of before the infiltration.
- **Long-term.** The infiltration lasted at least three months, throughout which the infiltrator maintained a consistent cover identity.
- **Targeting groups engaged in subversive activities.** This excludes infiltration targeting right-wing organizations, most political parties, and commercial companies.
- **In the 21st century.** All or part of the infiltration occurred after or during the year 2000.
- **Well documented.** There is a minimum amount of information available about where, when, and how the infiltration took place. Mere mention of an infiltration case in a news article or court document is not enough.

## Other resources

- He exhibited suspicious behavior, such as pushing people to commit crimes.
- Activists obtained FBI documents that appeared to be based on information he had provided. The documents included the names of many people, but not his name, and reported on private conversations he had with other activists.
- He then published an open letter admitting that he had worked for the FBI.

## Rachel Nieting (Amanda, Amanda Clara, Amanda Amey), 2007–2008

*Origin:* Civilian

Rachel Nieting infiltrated groups organizing against the 2008 Republican National Convention. She worked for the police. She attended meetings. Another infiltrator, **Marilyn Hedstrom** (p. 53), posed as her aunt.

# United States

## Zoe Elizabeth Voss (Anna), 2003–2006

*Origin:* Civilian

Zoe Elizabeth Voss infiltrated anarchist events and an informal anarchist group in the United States. She worked for the FBI. She attended events and demonstrations. She often wore hidden recording devices. At one event, she met an anarchist, Eric McDavid. They met a few more times. Finally, she rented an isolated cabin where she met with McDavid and two others. During their stay at the cabin, she pushed them to build a bomb to carry out a sabotage. They were arrested after purchasing supplies to build the bomb. Eric McDavid was sentenced to 20 years in prison, later reduced to 9 years.

## Brandon Darby, 2006–2008

*Origin:* Civilian

Brandon Darby infiltrated activist groups in the United States, including an informal group organizing against the 2008 Republican National Convention (RNC). He had been involved in activist groups for years before being recruited by the FBI. During the RNC, he wore a recording device hidden in his belt. His infiltration resulted in the arrest of two activists who were sentenced to 3 and 4 years in prison, respectively, for making and planning to use Molotov cocktails.

He was identified because:

# Australia

## *Unknown name (Setha Sann), 2006–2008*

*Origin:* Police

“Setha Sann” infiltrated left-wing, animal rights, and anti-war groups in Melbourne. He was part of the Security Intelligence Group, the intelligence unit of the police of the state of Victoria. He attended meetings and protests, and participated in actions.

# Austria

## ***Unknown name (Danielle Durand, Dani), 2007–2008***

*Origin:* Police

“Danielle Durand” infiltrated animal rights groups in Austria, including Verein gegen Tierfabriken (VGT, *Association Against Factory Farming*). She also attended events in the Netherlands and Switzerland. She attended meetings, demonstrations, and other events, and participated in civil disobedience actions. She formed friendships with her targets. On one occasion, she took two water bottles used by activists and gave them to the police so that they could collect the activists' DNA on the bottles. She had a sexual relationship with one of her targets. Her infiltration contributed to the prosecution of 13 activists, though they were all ultimately acquitted.

- After he vanished, activists failed to find him in official documents, such as electoral registers.

- Electoral records for his birth year did not include an entry for “Mark Stone” but did include an entry for a “Mark Kennedy” who was married.
- A genealogy website included an entry for a “Mark John Kennedy” who was listed as being married and having children.
- The birth certificate of the son of “Mark Kennedy” listed the father’s occupation as police officer.
- The birth certificate of “Mark Kennedy” listed the father’s occupation as police officer, despite his claims that his father was an accountant.
- The marriage certificate of “Mark Kennedy” listed his occupation as police officer.
- When confronted with evidence, he admitted to being an infiltrator.

## ***Unknown name (Gary Rayner, Gary John Rayner), 2006–2011***

#### *Origin:* Police

“Gary Rayner” infiltrated animal rights groups in Oxford. He also attended an event in Norway. He attended meetings and demonstrations, and helped organize events. During the first two years of his infiltration, he lived with a woman who was likely also a police officer.

He was identified because:

- After several infiltrators were identified in the United Kingdom starting in 2011, activists realized he fit the profile of an infiltrator.

## **Canada**

## **Bindo Showan (Khalid Mohammed), 2008–2010**

#### *Origin:* Police

Bindo Showan infiltrated groups in Ontario, including Southern Ontario Anarchist Resistance (SOAR). He was tasked with infiltrating anarchist groups organizing against the 2010 G20 Toronto summit. He first infiltrated a group organizing against the construction of a business park before moving on to infiltrate SOAR, the main anarchist group organizing against the G20. He attended meetings. Information he gathered helped incriminate SOAR participants.

He was identified because:

- He exhibited suspicious behavior, such as discussing illegal activities in inappropriate contexts and not stopping when asked to stop.
- An activist “saw something suspicious” on his phone.

## **Brenda Carey (Brenda Dougherty), 2009–2010**

#### *Origin:* Police

Brenda Carey infiltrated groups in Ontario, including Southern Ontario Anarchist Resistance (SOAR). She was tasked with infiltrating anarchist groups organizing against the 2010 G20

Toronto summit. She initially infiltrated an anti-poverty group before moving on to successfully infiltrate SOAR, the main anarchist group organizing against the G20. She attended meetings. She introduced a man she claimed was her boyfriend to other activists, and who was in fact another police officer. On one occasion, she wore a hidden recording device to a meeting. Information she gathered helped incriminate SOAR participants.

## **Denis Leduc (François Leclerc), 2009–2010**

#### *Origin:* Police

Denis Leduc infiltrated groups in Ottawa, including the Indigenous Peoples' Solidarity Movement of Ottawa and groups organizing against the 2010 G20 Toronto summit. He attended meetings and helped organize events.

He was identified during bail hearings, presumably through court documents.

## ***Unknown names (Kat and Alex), 2014–2015***

#### *Origin:* Unknown

“Kat” and “Alex” infiltrated the Toronto-based Mining Injustice Solidarity Network (MISN). Claiming to be a couple, they attended a few meetings and tried to find out what MISN was planning in opposition to the 2015 Pan American Games. Kat claimed to be a survivor of abuse in order to avoid answering questions about her past.

## **Mark Kennedy (Mark Stone, Flash), 2003–2010**

#### *Origins:* Corporate, Police

Mark Kennedy infiltrated many environmentalist, anti-capitalist, and anarchist groups in the United Kingdom and abroad. He participated in demonstrations, actions, and other events in Denmark, France, Germany, Greece, Iceland, Italy, Ireland, Poland, Spain, and the United States. He worked for the police as part of the National Public Order Intelligence Unit. In 2010, he also worked for a security company. He first infiltrated a social center in Nottingham, United Kingdom, before moving on to other groups. He had credit cards, bank accounts, a passport, and a driver's license under his fake name. On one occasion, he introduced two people he claimed were his childhood friends to his roommates, and who were in fact likely other undercover police officers. On one occasion, he used a modified watch to record his targets' conversations. He had many romantic and sexual relationships with his targets, including one that lasted six years.

His targets were unaware that he was married and had children under his real identity. He was identified because:

- One day, his long-term partner found his real passport under the name “Mark Kennedy,” as well as emails indicating that he had children.
- His long-term partner and other activists then found evidence of his real identity:

- In an attempt to confirm that he was an infiltrator, activists gave him false information, and the information ended up in the press.
- Activists showed his picture to someone at the university where he claimed to have studied, and the person recognized him and provided his real name.
- An Internet search using his real name revealed that he worked for C2-i International.

## ***Matthew Gibbons, 2008–2009***

#### *Origin:* Civilian

Matthew Gibbons infiltrated anti-fascist demonstrations in the United Kingdom. He worked for the police.

They were identified because:

- They exhibited suspicious behavior, such as asking suspicious questions and having suspicious social media profiles.
- One day, a person who suspected they were infiltrators followed them into a subway station. After noticing the person following them, Alex appeared to talk on the phone. Shortly after, two police cars arrived, and police officers ran out of the cars and into the station, as if they had been waiting nearby to protect Kat and Alex in case something went wrong and Alex had called them to ask them to intervene.
- A journalist investigating the story could not find Kat or Alex in public legal records and could not confirm that Kat lived in the neighborhood she claimed to live in, despite knocking on doors and talking to people in the neighborhood.

They pushed a group of anarchists to plot an attack on a train with Molotov cocktails. Their infiltration resulted in the arrest of five anarchists, one of whom spent a year and a half in pretrial detention, though they were all ultimately acquitted.

- She exhibited suspicious behavior, such as displaying a poster in her house that was more radical than her apparent beliefs, always keeping one room in her house locked, and preferring to sleep in hotels rather than in friends' spare rooms.
- Activists were unable to verify her claims that her family lived in Farnborough and that her first and second boyfriends were a locksmith from Northampton and a photographer from Coventry, respectively.
- After being identified himself, undercover police officer **Mark Kennedy** (p. 48) confirmed that she was an infiltrator.
- When confronted with evidence, the police confirmed to journalists that she was an infiltrator.

- His name did not appear on the electoral register of the city he claimed to live in, nor in the records of the sports team he claimed to have played for.

*Origin:* Unknown

“Dan” infiltrated groups in France, including groups participating in the grassroots “yellow vests” protests and groups organizing against the 2019 G7 Biarritz summit. She attended meetings and helped organize demonstrations and other events.

She was identified because:

- During a meeting, activists noticed that she was discreetly taking pictures with her phone.
- Activists then seized the phone and found that she had taken many pictures of meetings, demonstrations, and actions, and was sending information about activists to a supervisor.

He was part of the Special Demonstration Squad. He attended meetings and participated in events and demonstrations.

He was identified in 2004 after he accidentally left a voicemail on another activist's phone in which he spoke with police officers. He was expelled from Globalise Resistance but the identification was not made public, and he continued to infiltrate other groups until 2007.

- After several infiltrators were identified in the United Kingdom starting in 2011, activists realized he fit the profile of an infiltrator. In particular, he completely vanished in 2006.
- Activists failed to find him in Norway, the country he claimed he was moving to before vanishing.
- In 2024, a government inquiry into undercover police operations confirmed that he was an infiltrator.

## Manfred Schlickenrieder (Camus), 1975–2000

*Origins:* Corporate, Police

Manfred Schlickenrieder infiltrated a wide range of left-wing and environmentalist groups in Germany, as well as in Italy, the Netherlands, and Switzerland. In particular, he infiltrated various levels of left-wing revolutionary organizations, including the Red Army Faction in Germany and the Red Brigades in Italy. He worked for both State intelligence agencies and private companies throughout his career, including German domestic and foreign intelligence services and the security company Hakluyt, which had close links with British foreign intelligence services and provided information to the multinational oil and gas companies Shell and BP. He posed as a militant archivist, filmmaker, and translator, which allowed him to attend secret meetings, collect documents, and film interviews, meetings, demonstrations, actions, and other events. He gathered information on hundreds of activists. On one occasion, he offered to sell firearms to members of a clandestine communist party, and asked in exchange to know what the firearms would be used for.

- After several infiltrators were identified in the United Kingdom starting in 2011, activists realized he fit the profile of an infiltrator. In particular, no one had met his family, he tended to disappear for long periods of time, and he had completely vanished in 2006.
- Toward the end of his infiltration, he started a relationship with a woman who wasn't politically active. Activists discovered that a “Carlo Soracchi” had registered at the woman's address and found a document indicating that “Carlo Soracchi” was a police officer.
- During his infiltration, he showed an activist a photo album with pictures of his real family. Activists found these same pictures on social media associated with the name “Carlo Soracchi.”

He was identified because:

- He exhibited suspicious behavior. For example, in 2003, he requested to be named as a defendant in a civil court case against activists, presumably to gain access to their legal strategy. This was considered suspicious because activists would not normally want to be named as defendants as this would expose them to fines or other negative consequences.
- In 2004 or 2005, an activist revealed that a “well-placed contact within the security industry” had claimed that Gratwick was an infiltrator working for the security company Verify.
- In 2015, an activist learned that, in 2002, former infiltrator Jim Boyling (p. 36) had claimed that Gratwick was an infiltrator.
- In 2016, a company was founded at the address where the security company Verify had been based. The company listed two directors: Gratwick and the son of the founders of Verify.
- In 2025, he was accused of child sexual offenses. During the trial, as part of his legal defense strategy, he admitted that he had been an infiltrator.

- Activists found a birth certificate with his name and date of birth, as well as a death certificate with the same name dated two days later, indicating that he was using the identity of a deceased baby.

Ralf Gross infiltrated animal liberation, environmentalist, anti-repression, and anti-fascist groups in Germany. He worked for the police. He attended events and demonstrations, and participated in actions. On one occasion, the morning after an arson attack, he called an activist and asked if he had slept well, presumably to determine whether he had participated in the attack. He carried out the infiltration under his real name.

He was identified because:

- He exhibited suspicious behavior, which led activists to suspect him. For example:

- He had meat in his refrigerator and kept dogs in a kennel at his home, which was suspicious considering he participated in animal liberation groups.
- He reacted suspiciously when someone asked to borrow his laptop.
- Activists gained access to his email account and discovered that he had sent suspicious emails.
- Activists gained access to his Facebook account and found private messages in which he expressed disdain for animal liberation actions.
- In an attempt to confirm that he was an infiltrator, activists told him about a fake clandestine action, and later recorded a phone conversation in his car during which he gave information about the action to an unknown person.
- When confronted with the accusation that he was a spy, he tried to deny it, but he was not convincing at all.

## Gerrit Greimann, 2016–2018

- After the article was published, in an attempt to discover potential infiltrators, CAAT activists analyzed the emails sent from the group's office in 2002 and 2003. They found that Martin Hogbin had sent numerous emails containing sensitive internal information to a suspicious email address.
- When confronted with this fact, Martin Hogbin did not provide a plausible explanation for why he had sent the emails.

He was part of the Special Demonstration Squad. He attended demonstrations and participated in actions. He was in a romantic and sexual relationship with one of his targets.

In 2018, a government inquiry into undercover police operations revealed that he had been an infiltrator.

He attended hundreds of meetings, demonstrations and other events. On several occasions, he accused other activists of being infiltrators. He had romantic and sexual relationships with his targets, including one that lasted four years. He carried out the infiltration under his own name.

He was identified because:

- He asked his activist girlfriend to fix a problem with his computer.
- While trying to fix the computer, his girlfriend discovered that he had been sending suspicious emails containing information about activist groups.

# Norway

## Christian Høibø, 2002–2012

### *Origin:* Civilian

Christian Høibø infiltrated left-wing groups and a social center in Norway. He also attended demonstrations in Denmark and Germany. He initially began the infiltration for his own purposes—to gather information for his work as a journalist—and, in 2002, was recruited by the police to work as an infiltrator for them. He attended meetings and participated in demonstrations.

In 2013, he publicly revealed that he had been an infiltrator. The police confirmed that he had indeed worked for them as an infiltrator.

## ***Unknown name (Fernando Pérez López), 1997–2002***

*Origin:* Police

“Fernando Pérez López” infiltrated groups in Madrid. He first infiltrated prisoner support groups, before moving on to infiltrate the urban guerrilla Marxist-Leninist group First of October Anti-Fascist Resistance Groups (*Grupos de Resistencia Antifascista Primero de Octubre*, GRAPO). He attended and helped organize events and demonstrations. On one occasion, he introduced to other activists a woman whom he claimed was his mother, though she likely wasn't, as well as people whom he claimed were his friends, though they likely weren't. His infiltration led to the arrest of GRAPO members.

She was quickly suspected of being an infiltrator because she exhibited suspicious behavior, such as not having a social media presence. She was identified when members of Extinction Rebellion used a photocopy of her ID card to request a birth certificate from the city where she claimed to have been born, and discovered that she wasn't in the city's registry.

- When asked to show that he wasn't an infiltrator, he failed to do so and disappeared in very suspicious circumstances.
